ED conducts searches in multiple states over Gomti project case

THE ENFORCEMENT DIRECTORATE (ED) on Thursday conducted multiple searches across various states in connection with its money laundering probe into the ₹1,500-crore Gomti riverfront development project in Lucknow, official sources said.

The project was started by the previous Samajwadi Party (SP) dispensation.

Sources said the raids were being carried out in various premises of the accused and their associates in Uttar Pradesh (Lucknow and Noida), Delhi, Haryana and Rajasthan by a team of the Enforcement Directorate (ED) officials assisted by local police.
